FROM THE NORTH: Use Interstate 35E. Exit to Highway 121 South. Continue south on Hwy 121 then exit Freeport/Grapevine Mills exit. Continue on access road past Freeport to Grapevine Mills Rd. Turn left and NTA Taekwondo & Sports is on your right at the first light.

FROM THE SOUTHEAST: Use Interstate 45. Exit to Interstate 35E North. Exit to Highway 121 South. Continue south on Hwy 121 then exit Freeport/Grapevine Mills exit. Continue on access road past Freeport to Grapevine Mills Rd. Turn left and NTA Taekwondo & Sports is on your right at the first light.

FROM THE SOUTHWEST: Use Highway 121 North from the Fort Worth area. Exit Sandy Lake Road. NTA Taekwondo & Sports is on your right at the first light.

FROM THE EAST: Use the George Bush Turnpike (Highway 190). Exit to Interstate 35E North. Exit to Highway 121 South. Continue south on Hwy 121 then exit Freeport/Grapevine Mills exit. Continue on access road past Freeport to Grapevine Mills Rd. Turn left and NTA Taekwondo & Sports is on your right at the first light.

FROM THE EAST: Use Interstate 635 west and go north on Highway 121. Exit Sandy Lake Road and turn right. NTA Taekwondo & Sports is on your right at the first light.

FROM THE WEST: Use Highway 114. Exit onto Highway 121 North. Exit Sandy Lake Road and turn right. NTA Taekwondo & Sports is on your right at the first light.
